The Importance of the 10th Amendment to the Constitution

[TENNESSEE CITIZENS FOR STATE SOVEREIGNTY](#) is an organization of Tennessee citizens dedicated to educating the public on the importance of the 10th Amendment,

Nullification and The Anti Commandeering Doctrine by implementing a **state level process** to ensure our God given rights are protected. Go to the Substack for more information.

Nullification may have an opportunity to be heard again in next year's general session. A bill sponsored by Senator Janice Bowling (R-Tullahoma-District 16) in 2023 has an opportunity for a rehearing in the next General Session in January 2024.

The "**Restoring State Sovereignty Through Nullification Act**," establishes processes by which the General Assembly may nullify an unconstitutional federal statute, regulation, agency order, or executive order. The bill's aim is to codify the 10th Amendment, protect the sovereignty of the state and its right to nullify any federal action that is unconstitutional.

Some may not know, but the State Legislature passed a resolution in 2021 declaring the states' sovereignty and that the state had a right to nullify unconstitutional federal action and that this right was not limited to court action. This resolution was sponsored by House Speaker Cameron Sexton and Lt Governor Randy McNally. Looking at the record posted on the state site, almost all Republican senators and representatives present that day voted for the resolution. Both resolutions had numerous co-sponsors. The proof that they claim to believe in that is found in the vote of HJR9005/SJR8995 as amended in late October 2021 (www.capitol.tn.gov/Bills/112/Bill/SJR9005.pdf). See [Representative Bud Hulse's presentation](#) of the bill. The only recorded "no" votes came from liberal Democrats.
