A Quick Update on the IRS Scandal:

- Outgoing acting IRS Commissioner Steven Miller resigned earlier last week, stating that "As the acting commissioner, what happens in the IRS whether I was personally involved or not—stops at my desk. I should be held accountable." He testified in front of the House Ways and Means Committee on Friday.
- In the House Ways and Means hearing, Miller admitted to planting a question in the audience at a conference May 10th aided by a deputy at the IRS, Lois Lerner. The question was asked by Lerner's friend in a way that would expose the targeting of conservative applicants for 501(c) (4) status.

In response to Republican Rep. Peter Roskam of Illinois's question of why Miller did not come forward to the Ways and Means Committee earlier to reveal the situation, Miller responded that agency officials wanted to wait for the results of an audit by the Treasury Inspector General for the Tax Administration's report. Miller was first briefed on the targeting of conservative groups as early as May 3, 2012. Miller admitted in a letter to members of Congress that those under him at the IRS knew that conservative groups were being targeted as early as June 2011. Lois Lerner discovered the targeting on June 29, 2011.

Writing our Representatives is important!! Correspondence from Senator Alexander

Dear Marie,

Thanks for getting in touch with me to share your concerns about the Marketplace Fairness Act. When you buy something online or from an out-of-state retailer, under state law you owe the same state sales tax that you would pay if you had purchased it at the local store. But most online sellers don't collect the state sales tax, and many purchasers don't pay it, even though it's owed. Keeping track of all your online and out-of-state purchases is something even

an accountant might have a hard time doing, so many Americans are failing to pay sales and use taxes they owe on these purchases. Some argue that the Marketplace Fairness Act would create a new "Internet tax." This is wrong. We are talking about the plain old state and local sales tax--all of us in Tennessee and 45 other states already owe. In Tennessee, you can learn more about sales and use taxes and complete the return online at https://apps.tn.gov/usetax/.

States should have the right to decide for themselves whether to collect – or not to collect – the state sales taxes that are already owed the same way they do from local stores. Government should not pick winners and losers in the marketplace, and the current policy has created a great big tax loophole that subsidizes some taxpayers at the expense of others and some businesses over others. States could reduce tax rates if they were able to collect taxes that are already owed from everyone who owes them. In Tennessee we could reduce the sales tax or avoid a state income tax, which are possibly the most hated words in our tax vocabulary in Tennessee.

That's why I cosponsored the Marketplace Fairness Act, and joined 68 other Senators on May 6 to pass this bill which gives states the right to set their own tax policies without playing 'Mother, may I?' with the federal government. This bill honors the conservative principle of not picking winners and losers among taxpayers and businesses. It is about stopping the subsidization of some taxpayers over other taxpayers and stopping the subsidization of some businesses over others. Congress has been trying to solve this problem for years, and the Marketplace Fairness Act is bipartisan legislation offering states two ways to make it simple for out-of-state sellers to collect state sales taxes.

I'm grateful that you took the time to get in touch with me. Your comments are important to me and I'll be sure to keep them in mind as the bill now awaits consideration and passage in the House of Representatives.
